The taxonomy should be used by those who prepare Financial Statements according to PSAK for Financial Statement reporting to Indonesia Stock Exchange. Indonesia Stock Exchange does not claim that this taxonomy is comprehensive. Organizations using this taxonomy may need to add extension taxonomy.
